(tabled - October 11, 2022) Randy Jackson reported to the Court the past commissioner court minutes pertaining to the three ambulance services. Darin Wolf discussed the unincorporated areas that Archer City Ambulance was covering now, and stated if Archer City no longer had a service, then the money should go to AMR. Megan Randall provided the contract and the City's budget between the City of Archer City and AMR ambulance service. Ms. Randall discussed the contract and the City's budget. Randy Jackson reported that Pete Wolf was asked to be at the meeting to represent his company, but was unable to attend. George Huffman reported to the Court that the City still had the ambulance service under the city's umbrella. The City is simply subcontracting out the service. Shane Wright reported that the Archer City Fire Department will be FRO (First Responder Organization) compliant within the next 60 days. Paula Brandley reported that the City discussed the \$15,000 supplement with Pete Wolf and also the cost of \$25,000 to purchase a heart monitor requested by AMR. David Levy advised if the Court continued to pay the City of Archer City an ambulance supplement, the payment would need to be designated as funds for the ambulance. Paul O. Wylie, Jr. did not see any reason the Court should not pay the funds to the City of Archer City. Pat Martin, III advised the Court that he was on the Court when the three

ambulance services drew up the unincorporated map themselves. Martin and Todd Herring agreed the supplement was for the unincorporated areas in the County and the City should continue at this time to receive the supplement.

ORDER TO CONTINUE SUPPLEMENT
