9. Consider and/or take action on County Investments. Patricia Vieth reported that five Certificate of Deposits were nearing the end of their term. Ms. Vieth and Paul O. Wylie, Jr. were asking for authority to reinvest the CDs in the depositories with the best interest rates.

ORDER TO APPROVE INVESTMENTS

The motion was made by Darin Wolf and seconded by Todd Herring to approve Patricia Vieth and Paul O. Wylie, Jr. to reinvest County's Certificate of Deposits where the highest interest rates are available. Voting yes 1-2-4-Judge; Abstain 3

10. Consider and/or take action on Courthouse repairs. Patricia Vieth discussed that the District Judge's Office has a crack on the inside walls. Mooring Construction fixed the outside of the Courthouse. Pat Martin, Ill reported that the roof leaked on the Courthouse, and Justin Piper with J. Menasco Roofing Company is going to come to work on the roof. Randy Jackson reported that Skipworth Construction in Wichita Falls repaired walls inside the Courtroom in the past and the cracks have not reappeared.

ORDER TO APPROVE REPAIRS

The motion was made by Todd Herring and seconded by Darin Wolf to approve preparations for Courthouse repairs associated with the south wall. Voting yes 1-2-3-4-Judge

11. Discuss and/or take action on Show Board Management. Removed.

12. Discuss and/or take action on Emergency Service Center. Randy Jackson reported that Wade Scarbrough had come by his office to discuss compliance with Local Government Code regarding the amount of work to be done with disabilities act. Wade Scarbrough asked with the amount of work to be done, does an architect need to be involved. Texas Administrative Code 1.212 requires an architect to be involved if the total project costs exceed \$50,000.00. Scarbrough also stated that there is a \$50,000 minimum that can be spent without having to be complaint with the American Disability Act. David Levy agreed with Commissioner Scarbrough that \$50,000 is the minimum that can be spent without having to be complaint with the American Disability Act. Randy Jackson reported that on the 9th of November an asbestos test was conducted on the building.

ORDER TO REACCESS PROJECT

The motion was made by Randy Jackson and seconded by Wade Scarbrough to do a cost assessment once an architect is hired and the asbestos test results are delivered to see if it will be feasible to continue work on Emergency Service Center. Voting yes 1-2-3-4-Judge
