Walnut, Archer City, Texas to discuss and/or consider for possible action the following listed items. Please note that the Court retains the right to consider items listed on this Agenda in no particular order. If lunch is observed in which a quorum of the Court will be present, the Court will recess to an announced location and the expected time of return if there is a need to reconvene back into open session to address remaining agenda items.

B. PUBLIC COMMENTS

Speakers are limited to THREE (3) minutes maximum, and if there are more than three speakers who wish to address the same item, the Court reserves the right to limit speakers. THE COURT CANNOT DELIBERATE OR ACT ON MATTERS NOT LISTED ON THE AGENDA.

C. ACTION AGENDA:

All items listed below are to be deliberated and considered for specific action by the Court. If no action is taken, the minutes will reflect as such.

- 1.) Approve Resolution and Agreement to implement the TxDot CETERZ Grant.
- 2.) Approve other Actions as necessary for implementation of TxDot CERTZ Grant
- 3.) Consider Departmental input and other actions, if necessary, related to implementing and improving I.T.issues
- 4.) Approve county wide ban on sale and use of certain fireworks identified as "skyrockets with sticks" and "missiles with fins" as stated in 49 Code of Federal Regulations, § 173.100 (r) (2) as authorized by Local Government Code §352.051
- 5.) Consider approval of Local Declaration of Disaster and Order banning sale and use of all other fireworks in Archer County as authorized by Local Government Code 410.108, for an additional period of time beginning on a date specified by Commissioner Court order.
- 6.) Approve a new county-wide burn ban to begin June 10, 2014 (after expiration of current burn expires which expires June 10, 2014) as authorized by Local Government Code §352.081
