NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of 0.72214 per \$100 valuation has been proposed by the governing body of City of Megargel.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for City of Megargel from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that City of Megargel may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for City of Megargel exceeds the voter-approval tax rate for City of Megargel.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for City of Megargel, the rate that will raise \$500,000, and the current debt rate for City of Megargel.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Megargel is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on **September 08, 2020 at 6 pm** at Megargel City Hall 1302 Cedar Street Megargel TX.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Megargel is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Archer County of City of Megargel at their offices or by attending the public meeting mentioned above.
