### **Budget Workshop**

#### **Items discussed:**

EMC salary of \$41,000.00 County no longer receives a grant for half of EMC budget.

Raising fuel cost for Sheriff's Office and Commissioner's precincts.

4% to 6% increase for health insurance.

County Attorney part-time position for Conner Deen at \$18.50 hour

County has received grants in the amount of \$850,000.00 recommending a grant writer position with a salary of \$25,000.00, requesting salary to go to Patricia Vieth or hire a

grant writer with 5% of grants received going to writer.

New Constable for Megargel, salary, new vehicle, health care and retirement.

Wayne McCullan, Veteran's Service Office increase salary from \$400.00 per month to \$1,000.00 month.

Joshua Smartt requested additional part-time position to work as a school liaison for the County

Agents working 20 hours a week at \$15.00 per hour.

Cost of living increase request ranging from 4% to 10%

Sheriff discussed adding \$13,000.00 to IT budget in non-departmental to replace computers for Sheriff's Office.

Add an Out of County Inmate Housing budget to show income and expenses from inmates being house by Archer County.
