When Mr. Deen passed the bar in April of this year, he felt Mr. Deen would be an asset to his office as the Assistant County Attorney. David Levy reported that appointing Mitzi King as the Victim Assistance Coordinator allowed her to be eligible for SB22 funding as well. Mr. Levy stated Deen would be considered a new hire for the County Attorney's Office. Patricia Vieth questioned the portion of the salaries the County was paying. Vieth interpretation of SB22 was the County had to pay the normal salary and the SB22 would pay the additional funds. No action taken.
