2. Discuss and/or take action on Budget Items. No action taken

Discussion:

Pat Martin, III stated that the Court needs to move the July 22, 2024 date to approve Elected Officials' salaries because of the pending tax rate. Dawn Vieth informed the Court that she is expected to get the tax values from Kimbra York, Chief Appraiser, by July 25, 2024. Ms. Vieth has to present the proposed tax rates to the Court no later than August 7, 2024.

Pat Martin, III wanted to revisit the Constable positions that are wanting to request SB22 Funds. Randy Jackson stated that other counties our size have only one or two Constables, and he believes Archer County has too many Constables for a county of our size with budgets over \$60,000 per year. Mr. Martin believes we should take advantage of the SB22 funds while they are available. In his opinion, SB22 took away the Commissioners' authority to set salaries.

Wade Scarbrough discussed the information he had distributed at the last Commissioners' meeting regarding purchasing a new trailer. Mr. Scarbrough is recommending the Nuttall Trailer at a cost of \$35,425 (including delivery fee) for Precinct 5. Pat Martin, III suggested making sure it would be able to haul a dozer. After discussion, the Court postponed making any decisions.

Having no further business to consider, the Court adjourned at 11:35 a.m.
