- 12. Update on the Archer City Ambulance Service presented by Ronnie Meyer.

 Ronnie Meyers reported that the Archer Ambulance Fund has been established as a 501(c)(3). Mr. Meyer advised the Court that the city has not gone out for bids on an Ambulance Service. He stated that there would be a price increase of 2.74% which would be a \$13,700.00 increase for the year. Randy Jackson stated that there was legislation that would help rural ambulance services. Jackson said that until it passed, the counties would not know if it was for new equipment or employees or both. Todd Herring discussed the issues of the ambulance not being in Archer City.
- 13. Discuss and/or take action on additional personnel in Tax Assessor-Collector office. Dawn Vieth requested an additional fulltime person in her office. Vieth stated that the county was growing at a rate that she needed additional help. Vieth asked, if possible, to let her start hiring while her office is slower to allow her to train the new position, since the employee had to complete 30 hours of training before they could use the State system. Darin Wolf and Todd Herring discussed the cost of a new employee. No action taken.
- 14. Discuss and/or take action on Employee overtime. Jack Curd discussed needing to pay dispatcher's overtime expenses. The dispatchers did not want comp-time because they never were able to get the time off.
