**Zach Rowe, with Dickey McGann & Rowe, gave an overview on our current Deductible amounts:**  
    **\$1,000 on Automobiles**  
    **\$2,500 on Property**  
    **\$1,000 on Equipment**  
**Mr. Rowe explained that Archer County's premium is increasing by 15% this year, but Cristi Kellar included that amount in the Budget.**  
**Jack Curd asked about insuring the ACSO drones. Mr. Rowe will check the cost to cover drones, mentioning that it would be expensive to cover them.**

#### **ORDER TO APPROVE INSURANCE**

The motion was made by Todd Herring and seconded by Kendall Coleman to approve Property and Casualty Insurance from Dickey McGann & Rowe. Voting Yes 1-2-3-4-Judge

13. Consider and/or take action on Holiday Closings for 2026. (tabled 12-8-2025)

**Randy Jackson led the discussion reporting that Texas Association of Counties (TAC) sent a statement regarding their holiday closings for next year, which includes eight days that banks are closed. He mentioned that we have 12 holidays.**

The motion was made by Darin Wolf to approve the same holiday closing schedule as 2025. The motion died for lack of a Second.

#### **ORDER TO APPROVE HOLIDAY SCHEDULE**

The motion was made by Randy Jackson and seconded by Kendall Coleman to include Columbus Day as a holiday and eliminating July 3<sup>rd</sup>. Voting Yes 2-3-4-Judge; No 1

14. Discuss and/or take action on policy regarding employees subject to the §207(K) Exemption. (tabled 12-9-2025)  
**Randy Jackson reported that there was a Special Called Meeting with TAC on this subject. Cristi Kellar stated that she continued to meet with the TAC representative for several hours, providing details of that discussion. Jack Curd mentioned that he wants to keep vacation as "time worked."**

### **ORDER TO TABLE APPROVING POLICY**

The motion was made by Randy Jackson and seconded by Kendall Coleman to table Approving the Policy regarding employees subject to the 207(K) Exemption until work is done on the language of the Policy. Jack Curd and Cristi Kellar both provided comments. Voting Yes 1-2-3-4-Judge

15. Discuss and/or take action in regards to Employee Incentive Pay.

**Kendall Coleman led the discussion, recommending full incentive pay of \$700 for all employees who have been with the county for one year. There were several comments from Cristi Kellar, Jack Curd and Patricia Vieth, who explained partial pay. Darin Wolf asked if there were funds in the budget to cover the increase.**

The motion was made by Kendall Coleman to pay all employees the incentive pay of \$700.00 that have been working for the County starting January 1, 2025. Motion died for lack of Second.

### **ORDER TO TAKE NO ACTION ON INCENTIVE PAY**

Darin Wolf made the motion and seconded by Wade Scarbrough to take No Action in regards to Employee Incentive Pay. Voting Yes 1-2-3-4-Judge

16. Consider and/or take action on Agreement for Mutual Aid in Fire and Emergency Services Between Sheppard Air Force Base and Archer County.

**Shane Wright mentioned that he emailed a copy of the Agreement to the Commissioners, and he discussed it with Tyler Sales.**

### **ORDER TO APPROVE AGREEMENT**

The motion was made by Todd Herring and seconded by Kendall Coleman to approve Agreement for Mutual Aid in Fire and Emergency Services between Sheppard Air Force Base and Archer County. Voting Yes 1-2-3-4-Judge
